1. INTRODUCTION

3. PRINCIPLES OF EYFS

- Learning and development differ for each child, acknowledging their individual needs.

4. LEARNING & DEVELOPMENT AREAS

EYFS covers **seven areas of learning**, divided into:

 2. Physical Development
 3. Personal, Social & Emotional Development
- **Specific Areas**:
 4. Literacy
 5. Mathematics
 6. Understanding the World
 7. Expressive Arts & Design

5. PLANNING & ASSESSMENT

- **Observations & Assessments**: Children's progress is regularly observed and documented to tailor learning experiences.
- **Two-Year Progress Check**: A mandatory assessment is conducted for children aged 2-3 years.

- ****EYFS Profile****: Completed at the end of the Reception year to assess school readiness.

6. PLAY-BASED LEARNING

- Kidsworld Nursery promotes ****play-based learning****, balancing child-led and adult-supported activities.
- Outdoor learning is incorporated to support physical and cognitive development.

7. INCLUSION & EQUALITY

- We provide ****equal opportunities**** for all children, including those with Special Educational Needs (SEN).
- Additional support is provided to children who need extra assistance.

8. PARTNERSHIP WITH PARENTS

- Parents are actively involved in their child's learning journey.
- Regular updates, meetings, and observations are shared with parents to ensure strong communication.

9. SAFEGUARDING & WELFARE REQUIREMENTS

- All staff are trained in ****safeguarding and child protection**** procedures.
- A ****safe and secure**** environment is maintained for all children.
- Health, safety, and well-being are prioritised through hygiene practices, risk assessments, and first aid.
